Requirements from the Contractor-

The transporter sending quotation for the tender must qualify following criteria to be eligible for participation-

- Applicant contractor should be actively handling the canteen/mess of large scale organizations in Manufacturing or Service Sectors. It should also have a recognized list of active clienteles in regions of applying the services.
- 2. Coal charged Bhatti is not allowed in our canteen/mess.
- 3. Utensils and all other cooking/serving equipment will be from canteen contractor
- 4. Minimal daily deployment of manpower in canteen is 14 man-days per day, that can go high based upon contractor's management or factory's requirements.
- 5. The contractor should have following mandatory documents ready to be send along with quotations.
 - Constitution of the firm
 - Certificate of Incorporation / Registration
 - Company profile
 - Address proof of registered office
 - PAN Number of owner/director and Firm
 - TAN of Firm
 - Relevant registration to operate as canteen contractor / FSSI License or Registration
 - GST Registrations certificate

The quotations are to be sent along with the mandatory document's checklist as prescribed above in this paper.

After receiving the quotations, organization will start sending "Invitation to Apply (ITA)" to selected service providers. ITA will provide a date and time to vendor on which meeting with Organization's HR Head will be conducted to discuss the preposition.

On qualifying all the criteria, contractor and organization will run in a formal agreement valid for 1 year (with renewable clauses). All terms and conditions pertaining to the deployment of buses, billing of services and arbitration will be written in Agreement.
