In continuation of our earlier intimation dated May 29, 2025, this is to inform you that the Hon'ble National Company Law Tribunal, Chandigarh Bench ('NCLT'), basis its hearing held today i.e., on July 17, 2025 has approved the Scheme of Arrangement for Amalgamation of Ind-Swift Limited ("Transferor Company") with Ind-Swift Laboratories Limited ("Transferee Company" /"the Company") and their respective shareholders and creditors ("Scheme"/ "Scheme of Arrangement"), under Sections 230 and 232 of the Companies Act, 2013 read with rules framed thereunder. The Appointed Date for the approved Scheme of Arrangement is March 31, 2024.
